# RATIONALE FOR CHANGES TO SECONDARY HEALTH EDUCATION LICENSE ADDITION PROGRAM October 4, 2018

The School of Public Health faculty member and academic advisor responsible for advising students in our Health Education Teacher Preparation Program recommend adoption of the attached revised Health Education License Addition program of study; 18 required credits with 4 recommended additional credits are being recommended.

Following is the rationale for this proposal:

- The proposal includes essential coursework that, when combined with Secondary Teacher Preparation Program required courses plus pedagogy courses completed in a different teaching major, will minimally qualify students for health education licensure. The number of required credit hours will make completion of the Health Educator License Addition more readily attainable.
- The required course work provides a strong overview of current health issues through H263 Personal Health and in-depth knowledge of the content area which is most controversial through F255 Human Sexuality. Additionally, students can complete both H263 and F255 for Gen Ed credit under the Social and Historical category.
- Students also will be required to complete specific foundational courses in health education pedagogy, H352 Secondary School Health Curriculum and Strategies, and school health programming in H464 Coordinated School Health programs. Both courses will prepare them for addressing student health issues in schools through health education and in coordination with professionals in other health-related programs and services (e.g. school nurses, food service directors, counselors, resource officers, physical education teachers, administrators, etc.).
- Students must also complete two of four concentrated content course options related to current critical health issues. This optional coursework will provide students with additional in-depth expertise while accommodating their individual interests. One of the four courses, H174 Prevention of Violence in American Society, can also be completed for Gen Ed credit under the Social and Historical category.

Indiana schools are in need of teachers who are licensed to teach health education. Traditionally, IUB has produced many health-certified teachers who majored in the PETE program provided through the School of Public Health, Department of Kinesiology; however, with the discontinuation of PETE that supply stream will no longer exist. One way to compensate is to provide a reasonable avenue to health education licensure for School of Education Secondary Teacher Preparation Program students majoring in any other subject areas, including journalism and theatre, who can transfer professional skills and abilities (e.g., classroom management, assessment construction, course design, etc.) learned in conjunction with their major to health education. Given the current broad societal interest in child and adolescent health and its link to academic achievement, this combining of health education licensure with licensure in other subjects could motivate IU School of Education graduates to expand options and add richness to the educational experiences provided in Indiana secondary schools.

The Department of Applied Health Science will also be redoubling efforts to recruit more students to the Secondary Health Education Teacher Preparation Program. The proposed revision to License Addition for Health Educator is a step in that direction.
