Transferring prior graduate work: Students entering with a Master's degree in counseling are typically able to transfer up to 30 credits toward their doctoral degree. These courses must be the substantial equivalent of required courses in the Counseling Psychology program. A course can only be transferred it it is current. If a course was taken more than seven years prior to the student passing the the oral portion of their qualifying examination, it must be revalidated. Information on revalidating courses can be found in the Graduate Bulletin. A total of 60 credits (including dissertation credits) must be taken at the Bloomington campus. Ph.D. students must have two consecutive semesters in a single academic year in which 9 hours of program course work (excluding dissertation credits) are completed each semester.
