### **Practicum Description Summary**

Practicum students will observe and participate in academic/career planning meetings with undergraduate tech students (Informatics, Computing, and Engineering) in order to learn and practice effective exploratory advising practices. In addition, they will pursue a subarea of responsibility based on their individual interest areas. Subareas might include:

- **Research**: explore approaches to advising based on advising theory and professional standards, with the goal of publishing in a relevant journal
- **Assessment:** determine the effectiveness of the practicum site's advising practices using quantitative and/or qualitative methods
- **Experiential Learning:** plan job shadowing opportunities for students and participate in advising outreach projects/events
- Curriculum Planning & Teaching: assist in implementing innovative teaching practices for an academic/career exploration course

- Practicum students will be able to create and implement advising assessments based on the NACE and NACADA standards.
- Practicum students will be able to articulate how academic and career advising work together to support student success, and they will be prepared to create approaches to connect the two areas within their academic units.
- Practicum students will be able to address the specific academic and career needs of undergraduate students interested in technology.
- Other possible learning outcomes include: planning and implementing outreach events, group advising, and classroom teaching sessions, as well as networking with fellow academic and career advisors on campus.

- Shadow advisors and eventually transition to conducting the advising appointments by themselves.
- Occasionally attend staff meetings of the academic and career advising staffs
- Create academic & career advising tools (binders of materials, handouts, posters, and other physical or virtual materials)
- Devise a personal approach to academic advising
- Create an advising assessment instrument for SICE advising
- Participate in supervisors' research, with the goal of developing articles/presentations for submission to academic journals and conferences.
- Other possible activities: campus outreach events, career fairs and other networking events.
