- Students must complete 15 credits for the minor. At least 9 credits must be at the 300 or above level. A grade of C or higher is required in each course and a 2.0 GPA overall for the minor.
  - Only one (1) education course may overlap between an education program and an academic minor.
  - No course overlap is allowed between academic minors and/or certificates. (For example, EDUC-H 340 cannot be used to fulfill a requirement in both the Education Policy Minor and International and Comparative Education minor.)
